**APPENDIX.**  
**NOTIFICATION.**

In exercise of the powers conferred by section 113 read with section 122 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Regularisation of Unapproved Layouts and Plots Rules, 2017, namely:-

**AMENDMENTS.**

In the said Rules,-

- (1) in rule 5, in sub-rule(1), after the proviso, the following proviso shall be added, namely:-  
"Provided further that any application which is received on or after the 4<sup>th</sup> November, 2018 under rule 24 from eligible plot holder shall be dealt with in the manner provided therein."
- (2) after rule 23, the following rule shall be added, namely:-  
"24. In respect of cases of plot regularisation for which in-principle approval of layout framework have already been accorded or under consideration by the Competent Authorities specified in rule 2(2)(ii) as required by sub-rule (4) of rule 5 as on the 3<sup>rd</sup> November, 2018 on suo-moto basis or otherwise and the cases for which in-principle approval of layout frame work is under consideration of the Competent Authorities in respect of the applications received under sub-rules (1) and (2) of rule 5 on or before the 3<sup>rd</sup> November, 2018, a plot holder may apply even after the 3<sup>rd</sup> November, 2018 for regularisation of plot under this rule. If any application is received under this rule, the following procedure in addition to other procedures laid down in these rules shall be followed in respect of regularisation of unapproved Plots, namely:-

On receipt of an application, if any, made by the plot holder on or after 4<sup>th</sup> November, 2018, in addition to the scrutiny fee and development charges as envisaged in these rules, the

regularization charges shall be assessed and levied at the rates given in the table below:-

Explanation I - The regularisation of plot relating to cases of unapproved layouts in respect of which neither the individual plot holder concerned nor the developer concerned has not applied for regularisation on or before 03.11.2018, shall not be eligible for consideration of regularisation under this rule.

Explanation II - A layout promoter also shall be considered as a plot holder in respect of unsold plots in a layout for the purpose of this rule.

**Sub:** CMDA – Regularisation of unapproved Layout Division – Unapproved Layout / Plot Regularisation Scheme – Government order dated 05.02.2019 – Action to be taken - Requested – Regarding.

The Government ordered in the references 1<sup>st</sup> to 3<sup>rd</sup> cited above, for regularization of unapproved layouts/sub-divisions/plots effected on or before 20.10.2016. Accordingly, CMDA is approving the in-principle layout framework / layouts and forwarded the same to concern local bodies, requesting to regularize the individual plots within the approved in-principle layout framework / layouts after collecting the regularisation charges and development charges applicable under this scheme.

2. The approved in-principle layout framework / layouts are being regularly hosted in CMDA website viz. [www.cmdachennai.gov.in](http://www.cmdachennai.gov.in) for the interest of public and other departments including the local bodies concerned.

3. Subsequently, the Government ordered in the reference 4<sup>th</sup> cited that the individual plot holder / developer concerned within the in-principle layout framework / layouts approved by Competent Authority only be regularized under the provisions of above said Government Order.

4. In view of above, the local bodies viz. Greater Chennai Corporation, Municipalities, Town Panchayats and Panchayat Unions within Chennai Metropolitan Area are requested to receive the regularisation application directly for the regularisation of individual plots which are covered within the in-principle layout framework / layouts approved by CMDA and after verification of the same from its website. The scrutiny fee of Rs.500/- per plot may also be collected by the local bodies concerned from the individual plot owners and the same has to be remitted in favour of **the Member-Secretary, CMDA in Account No.100034132198 with IFSC Code No.INDB0000328 in M/s. IndusInd Bank.**

5. Further, the local bodies concerned within CMA are also requested strictly adhere the Government Orders cited on the regularisation of unapproved plots / layouts / sub-divisions under this scheme and also furnish the status report in every week including the collection of regularisation charge and development charge separately.
